ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the opening, for application or recommendation, of three positions of **Regular Member of the Legal Education Board** representing the (1) **Philippine Association of Law Schools**; (2) **Philippine Association of Law Professors**; and (3) **Integrated Bar of the Philippines**.

The Regular Members of the Board must be **natural-born citizens** of the Philippines and **members of the Philippine Bar**, who have been engaged for at least **ten (10) years in the practice of law**, as well as in the **teaching of law** in a duly authorized or recognized law school (Sec. 4, R.A. No. 7662).
