In case of recommendations, the recommendees must signify their acceptance on or before the said deadline either in the recommendation itself or in a separate document.

New applicants or recommendees for the said positions in appellate courts must submit the following not later than **3 OCTOBER 2012** and those for judgeship positions, not later than **23 OCTOBER 2012**.

Clearances from the NBI, Ombudsman, IBP, Police from place of residence, Office of the Bar Confidant, and employer
Transcript of Law School Records
Certificate of Admission to the Bar (with Bar rating)
Income Tax Return for the past two (2) years

Proofs of age and Filipino Citizenship
Cert. of Good Standing or latest official receipt of payment for IBP dues
2010 & 2011 Sworn Statements of Assets, Liabilities, and Networth (SALN) – for those in government
2011 SALN – for those in the private sector

Certificate of Compliance with, or Exemption from, MCLE
Results of medical examination and sworn medical certificate with impressions on such results, both conducted/issued within 2 months prior to the filing of application

Previous applicants who are applying for the above-mentioned vacancies must inquire from the Secretariat about their lacking or out of date application requirements and must submit them not later than the deadline aforementioned.

APPLICANTS WITH INCOMPLETE OR OUT OF DATE DOCUMENTARY REQUIREMENTS WILL NOT BE INTERVIEWED OR CONSIDERED FOR NOMINATION.
