## ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the

1. Extension of the submission of applications or recommendations for the position of *Chief Justice of the Philippines*, together with the Personal Data Sheet, to **2 July 2012 (Monday)** and the submission of other documentary requirements to **17 July 2012 (Tuesday)**;

2. Deletion from Rule No. JBC-10 (promulgated on 23 September 2002) of the second and third paragraphs of Section 5, which read: "The proceedings shall be in writing. Cameras and tape recorders, however, shall not be allowed inside the [interview] room. No live TV and radio coverage of the proceedings shall be permitted"; and
