ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the opening, for application or recommendation, of the position of **ASSOCIATE JUSTICE OF THE SUPREME COURT** (vice **Hon. Maria Lourdes P.A. Sereno**, who was appointed Chief Justice on 24 August 2012), as well as the re-opening of the positions of **REGULAR MEMBER OF THE LEGAL EDUCATION BOARD (LEB)** representing the (1) Philippine Association of Law Schools; (2) Philippine Association of Law Professors; and (3) Law Students' Sector.

Applications or recommendations, together with six copies of accomplished Personal Data Sheet (forms are downloadable from the JBC Website <http://jbc.judiciary.gov.ph>), must be submitted not later than **17 September 2012 (Monday)** for the position of Associate Justice and **5 October 2012 (Friday)** for the LEB positions to the JBC Secretariat, 2nd Flr. Clearances from the NBI, Ombudsman, IBP, Police from place of residence, Office of the Bar Confidant, and employer
Transcript of School Records
Certificate of Admission to the Bar (with Bar rating)
Income Tax Return for the past two (2) years

Proofs of age and Filipino Citizenship
Cert. of Good Standing or latest official receipt from the IBP
Certificate of Compliance with, or Exemption from, MCLE
Sworn Statements of Assets, Liabilities, and Networth for the past two (2) years

Certification as to the number of years in the teaching of law (for LEB candidates only)
Results of medical examination and sworn medical certificate with impressions on such results, both conducted/issued within 2 months prior to the filing of application
