## ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the opening of the position of **Presiding Justice of the Sandiganbayan** (*vice Hon. Francisco H. Villaruz, who will retire on 8 June 2013*).

Likewise, the JBC makes it known to the public that it is still accepting applications or recommendations for the positions of REGULAR MEMBERS of the LEGAL EDUCATION BOARD (LEB) representing the (1) **Philippine Association of Law Schools** and (2) **Philippine Association of Law Professors**, both of whom are to be appointed for a term which will end on 13 January 2017. The Regular Members of the Board must be **natural-born citizens** of the Philippines and **members of the Philippine Bar**, who have been engaged for at least **ten (10) years in the practice of law**, as well as in the **teaching of law** in a duly authorized or recognized law school (Sec. 4, R.A. No. 7662). They shall have the same salary and rank as the Members of the Constitutional Commissions (Sec. 5, R.A. No. 7662).

Applications or recommendations (with conforme) for the Sandiganbayan position must be submitted in duplicate not later than **14 May 2013** and those for the LEB positions not later than **31 May 2013** to the JBC Receiving Section, Mezzanine, Supreme Court Centennial Bldg., Padre Faura St., Manila (Tel No. 552-9607; Fax No. 552-9598; e-mail address [jbc@supremecourt.gov.ph](mailto:jbc@supremecourt.gov.ph) & [jbc87supremecourt@gmail.com](mailto:jbc87supremecourt@gmail.com)), together with two copies of **newly accomplished** and notarized Personal Data Sheet with recent 2 x 2 ID Picture (JBC Form 1 – downloadable from the JBC Website <http://supremecourt.gov.ph>).

The following documents must be submitted by applicants for the Sandiganbayan not later than **29 May 2013**, and by applicants for the LEB, not later than **15 June 2013**.


