Applicants must be natural-born citizens of the Philippines and members of the Philippine Bar, who have been engaged for at least ten (10) years in the practice of law, as well as in the teaching of law in a duly authorized or recognized law school. Applicants for the position of LEB Chairperson shall preferably be a former Justice of the Supreme Court or the Court of Appeals.
