ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the opening, for application or recommendation, of the following positions:

A. LEGAL EDUCATION BOARD (LEB)

1. **Chairperson** (for a term from 15 January 2014 to 14 January 2019);
2. **Regular Member** representing the ranks of active law practitioners (for a term from 15 January 2015 to 14 January 2020)

Applicants for LEB positions must be natural-born citizens of the Philippines and members of the Philippine Bar, who have been engaged for at least ten (10) years in the practice of law, as well as in the teaching of law in a duly authorized or recognized law school. Applicants for the position of LEB Chairperson shall preferably be former Justices of the Supreme Court or the Court of Appeals. The Chairman and Regular member shall have the same salary and rank as the Chairperson and members of the Constitutional Commissions, respectively.
