  - Electrocardiogram (12-Lead)
- Medical Certificate with findings or impressions on the results of the said medical examination
- Income Tax Return or Certificate of Compensation Payment/Tax Withheld for the two preceding years

Certificate of Compliance with, or Exemption from, the Mandatory Continuing Legal Education Program (for private practitioners)\*

Two sample decisions/resolutions/ pleadings

Treatises, opinions, or articles written, edited, or published (if any)

Certification as to number of years in the teaching of law in a duly authorized or recognized law school (for LEB applicants only)\*
