ANNOUNCEMENT

The Judicial and Bar Council (JBC) announces the opening, for application or recommendation, of three positions of *Associate Justice of the Court of Appeals* (vice **Hon. Estella M. Perlas-Bernabe**, who was appointed to the Supreme Court on 16 September 2011, and **Hon. Rodrigo F. Lim, Jr.**, and **Hon. Mario L. Guariña III**, who will compulsorily retire on 25 October 2011 and 11 November 2011, respectively).
